PURPOSE OF THE POSITION

You will be responsible for providing expert and technical program and policy advice in DRR & ER support to the International Program Team (IPT), 6 Country Offices and the global ChildFund Alliance to ensure ChildFund Australia's international programs remain sharply focused to the rapidly increasing threats faced by children across the world.

KEY DUTIES

- Develop and maintain program initiatives related to DRR projects, general emergency response and child protection in emergencies (CPiE). This includes:
 - Supporting development, design and implementation of DRR, Climate Change Adaptation (CCA) and ER related projects implemented or funded by ChildFund Australia;
 - Expert advice in provision of gender and disability inclusion in DRR and ER programming;
 - Provision of evidence based capacity building to Country Offices and local partners in DRR and ER;
 - Managing contracts, projects and ER under the Australian Humanitarian Partnership (AHP);
- Participate in relevant Australia-based and international networks and working groups related to DRR and ER, including CPiE;
- Support ChildFund Australia's response to humanitarian emergencies across the world;
 - Review and maintain a set of recommended policies, program approaches and guidelines for ER, consistent with international standards and Sector commitment to localisation:
 - Focal point to support humanitarian-response efforts through a range of processes including: develop and review ER programs; seek partnership with expert ER and DRR agencies; monitoring and evaluation activity and field support visits.

- Minimum of five years' field experience overseas with an international or local NGO, ideally in an Emergency Response or DRR related role. Prior experience in a program or project-management role;
- Experience in developing strategic partnerships with specialised agencies and technical donors;
- Significant work experience in community development, in implementation, policy-development (disaster risk reduction, emergency response, technical support);
- Demonstrated commitment to gender and disability inclusion, human rights, children's rights and a child- centred approach to development;
- Significant experience writing high quality reports and well developed proposals.

ChildFund Australia is an independent and non-religious international development organisation that works to reduce poverty for children in developing communities. Our work is funded through child and community sponsorship, government grants as well as donations from individuals, trusts and foundations, and corporate organisations.

Remuneration Package

We aim to provide an overall remuneration package that is attractive and fair. Our remuneration framework ensures that we align to employment conditions and laws, and we benchmark against the local market to ensure we offer competitive employment conditions that are appropriate to our sector.

Leave

You will be eligible to salary packaging. As a Non-Governmental Organisation, our staff are eligible for salary sacrificing. The Australian Taxation Office (ATO) allows us to reimburse you for your personal expenses without having to pay any income or fringe benefits tax that would normally be payable. These tax concessions are in additions to the income tax Free Threshold.
