# Consultant's Terms of Reference for Meta-evaluation of ChildFund Australia Livelihood Projects

# 1. Organisational context

ChildFund Australia is an independent international development and humanitarian organisation that works to reduce poverty for children in developing communities. We work in partnership with children and their communities to create lasting change by supporting long-term community development, responding to humanitarian emergencies and promoting children's rights. We want every child to be able to say: "I am safe. I am educated. I am heard. I have a future."

ChildFund Australia implements programs with a range of local partners in Cambodia, Laos, Myanmar, Papua New Guinea, Timor-Leste, Vietnam, and other Pacific nations, and manages projects delivered by partner organisations throughout Asia, Africa and the Americas. Our work is funded through child and community sponsorship, government grants as well as donations from individuals, trusts and foundations, and corporate organisations.

ChildFund Australia is a member of the ChildFund Alliance – a global network of 11 organisations which assists 13 million children and their families in over 60 countries. ChildFund Australia is a registered charity, a member of the Australian Council for International Development, and fully accredited by the Department of Foreign Affairs and Trade, which manages the Australian Government's overseas aid program.

# 2. Background

In the past year, ChildFund Australia has reviewed and revised its organisational Monitoring, Evaluation and Learning Framework (MELF). The revised MELF has been designed to align with and reflect ChildFund Australia's current sector approaches which are Education, Child Protection, Disaster Risk Reduction and Emergency Response, Health and Social Emotional Learning<sup>1</sup>. These sectors are also aligned with the ChildFund Australia Strategic Plan 2015 - 2020.

ChildFund Australia also works in other areas including women's economic empowerment which can be closely linked with the other key sectors listed above. For example, while ChildFund Australia focuses on children, it may work directly with other groups such as mothers in order to improve their economic empowerment, which may be critical in enabling target mothers to provide improved care, health, education and standard of living for their children.

ChildFund Australia acknowledges that stronger livelihoods project analysis will inform how this issue can be more integrated into ChildFund program Sector of DRR/ER as a possible core component of effective development. Deepening our understanding and implementation of Livelihoods programming is seen as an important consideration in how we enhance our quality of programming.

<sup>1</sup> SEL programs focus on the processes through which children and young people develop and enhance the knowledge and skills necessary to understand, manage and communicate about their own emotions, feel and show empathy for others, establish and maintain helpful relationships, set and work towards goals, draw on a repertoire of coping strategies, think critically about what influences their choices, and make responsible decisions.

### 3. Purpose

Reporting to the ChildFund Australia Head of Programs, and in close consultation with the DRR/ER Advisor and MEL Senior Advisor the consultant will undertake a meta-evaluation of both agriculture and non-agriculture-based livelihood and economic empowerment initiatives. This review will incorporate a gender and inclusion perspective.

This process will inform our strategic program direction on the extent to which such initiatives can grow and be continued within the DRR/ER program or other more appropriate sectors depending on findings. Analysis and recommendations will be provided in a final report, which will inform improved design and planning of projects.

# 4. Scope of Evaluation

The Consultant will examine both the completed and ongoing projects and provide a written analysis of the findings informed by the following considerations:

- A clear understanding of what good practice and current approaches or innovations are
  evident in the selected project, including strength/weakness analysis of the livelihood
  models that worked and the factors that facilitated the positive outcomes and quality. This
  includes clear commentary on the livelihood models that did not work and the specific risks
  they may have contributed too. Consideration of where livelihood, economic
  empowerment and disaster risk reduction initiatives intersect and how can they
  complement each other within ChildFund Australia's Program Model and MELF.
- An insight into what the short-term and long-term outcomes of the selected Livelihood projects are. An analysis of the value-add of these outcomes to girls and boys, female and male youth, women and men, communities as a whole, and government/CSO partners, as applicable.
- How livelihood and economic empowerment projects have identified barriers to inclusion of
  marginalised groups and consider what they have done to include those of a different gender,
  people with disability, ethnic minority groups, poorest of the poor, etc. Cite evidence that
  shows how these groups have been/haven't been included and include recommendations of
  how this could be improved.
- Analyse ChildFund Australia's capacity to implement/co-implement livelihoods projects:
  - How does ChildFund Australia improve its capacity to design, implement, monitor and evaluate these projects to a high quality?
  - Does ChildFund Australia incorporate external skills into its economic empowerment projects when they are necessary (e.g. partners/consultants)?
  - What are the challenges encountered by the Country Offices and implementing partners the capacity gaps and solutions required to inform better quality livelihoods programming.
- Findings and recommendation that include; key lessons learnt, findings, and recommendations. programming next steps including what specific areas of intervention outcomes and target groups should it focus on so as to achieve greatest impact within livelihood and economic empowerment.

### 5. Methodology

The Consultant will utilise a desk review and key informant interviews, group interviews either (face-to-face or Skype) for information gathering and should work closely with the contract manager

during the course of work. In addition, the Consultant will visit three ongoing projects in Vietnam. See Annex 1 for list of projects.

#### 6. Deliverables and Indicative Timetable

The outputs will be a final report presenting the findings of the meta-evaluation. The report should present findings, analysis and recommendations against areas stated in the previous section. The initial report should be presented through a face-to-face workshop (if Consultant is Australia-based).
