ORGANISATIONAL CONTEXT

ChildFund Laos is the representative office of ChildFund Australia – an independent international development organisation that works to reduce poverty for children in developing communities.

ChildFund Australia is a member of the ChildFund Alliance – a global network of 12 organisations which assists almost 23 million children and their families in 70 countries. ChildFund Australia is a registered charity, a member of the Australian Council for International Development, and fully accredited by the Department of Foreign Affairs and Trade which manages the Australian Government's overseas aid program.

ChildFund began working in Laos in 2010 and works in partnership to create community and systems change which enables vulnerable children and young people, in all their diversity, to assert and realise their rights. Projects are implemented in the capital of Vientiane, as well as Huaphanh and Xiengkhouang Province, some of the country's poorest regions with significantly high unexploded ordnance contamination.

With a focus on upholding child rights and improving access to quality education, ChildFund in Laos also prioritises projects which focus on child nutrition, sexual reproductive health and rights, media literacy and job readiness.

Remuneration Package

We aim to provide an overall remuneration package that is attractive and fair. Our remuneration framework ensures that we align to employment conditions and laws, and we benchmark against the local market to ensure we offer competitive employment conditions that are appropriate to our sector.

In addition to salary payment, you will be provided Lao New Year Bonus, severance payment depending on staff's tenure with the organisation, mobile allowance, full insurance package (Life, Health and Accident) and health insurance coverage will be extended to your family members (spouse and children).

Additional allowance for field staff

Field staff are eligible for a one-off \$100.—relocation allowance when moving from once province to work in one of our projects in another province. They are also eligible to three home visits per year, hardship and accommodation allowance.

Leave

You will have access to 20 days of paid annual leave and up to 16 days of public holidays per year. You are also entitled to other paid leaves, including 180 days maternity leave, 15 days paternity leave, 30 days sick leave, 18 months long-terms illness leave, 5 days compassionate leave, 3 days marriage leave, 2 days family leave and study leave.

You will have access to flexible working arrangements. We encourage a culture of flexibility and enable conversations between yourself and your manager about maintaining work-life balance.
